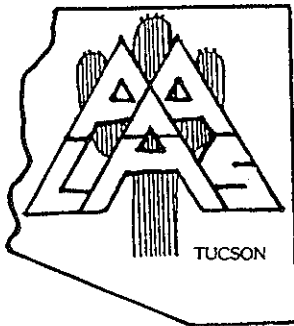

MINUTES OF THE PAST MEETING

AALAS has an Animal Technician Certification Program which serves two main purposes. It provides a mechanism for developing standards of competence for people who work in the field of laboratory animal science and it recognizes people who meet and exceed these standards by awarding them certification at three different levels: Assistant Laboratory Animal Technician, Laboratory Animal Technician, and Laboratory Animal Technologist.

In order to qualify for AALAS certification, applicants must pass their exams (written and practical) and meet educational and experience requirements which are outlined in the AALAS publication 83-1, "The Animal Technician Certification Program".

The minimum requirements to take the exams at each level are:

(1) Assistant Laboratory Animal Technician - must have completed grammar school, have 6 months of work experience in a laboratory animal facility and have education in animal science and/or relevant work experience totaling another 6 months.

(2) Laboratory Animal Technician - must have completed high school, have 2 years of work experience in a laboratory animal facility and have education in animal science and/or relevant work experience totaling another 2 years.

- (3) Laboratory Animal Technologist - must have completed high school, have 2 years of work experience in a laboratory animal facility and have education in animal science and/or relevant work experience totaling another 3 years.

Provisional certificates for all three certification levels are given to those applicants who meet the educational requirements and pass the examination (practical and written), but who do not yet meet the experience requirements. A provisional certificate is valid for 3 years.

A candidate may apply for provisional certification once the education requirement is met and his or her instructor makes the recommendation.

Once the experience requirements have been met, the candidate may apply for full certification.

TECHNICIAN/MEMBER OF THE YEAR NOMINATIONS

Nominations are now being accepted for this years' Technician/Member of the Year Awards. Only members in good standing may nominate. Nominees must meet the following criteria: be a member in good standing of the Arizona Branch of AALAS, have a year's worth of animal/animal related experience, be personable and get along with investigators and co-workers, make contributions to make operations run better, hold supervisor position or below.

WHAT'S NEW IN THE NEWS

Legislation

The final form of the new animal welfare regulations and standards for dogs, cats, and nonhuman primates resulting from the 1985 amendments to the Animal Welfare Act were published on February, 15, 1991 by the Animal and Plant Health Inspection Service (APHIS) of the USDA. This final version incorporates NABR member's suggestions that research facilities be required to develop individual institutional plans to address the requirements of the exercise of dogs and the psychological well-being of nonhuman primates. The new standards will be effective March 18, 1991, but research facilities will be given time to implement the changes. Written documents describing programs for dog exercise and environmental enrichment for nonhuman primates have been developed and implemented by August 14, 1991. These written plans and procedures must be available to APHIS inspectors.

Major capital improvements can be phased in over three years. In order to minimize the economic impact on institutions, compliance with six specific provisions which may require significant investment can be delayed until February 15, 1994.

iiFAR Asks Us to Write Letters

"The Home Show", weekday mornings on ABC, has shown many ironies in their understanding of the use of animals in research and product testing. They have been sympathetic to animal rights activists while continuing their own health spot reporting medical progress. On the December 18th episode, Sabrina LeBoeuf, who plays the oldest daughter on "The Cosby Show", appeared promoting PETA's line of "Cruelty Free" products. 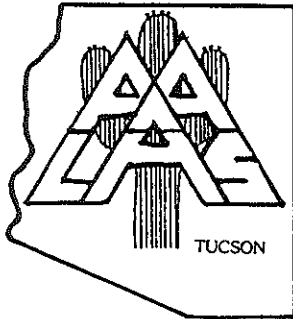

Their presence brightens the day of residents who may have no other visitors. The dogs and sometimes cats can bring a smile to the face or a greeting to the lips of people who show no recognition of other humans, including their own family members.

Some therapy dogs and their owners visit facilities on an individual basis. Others make their calls as part of local dog clubs or scouting organizations.

Of course, basic obedience training is a prerequisite for therapy dogs. They should be friendly, but not so exuberant that they might scare their friends. 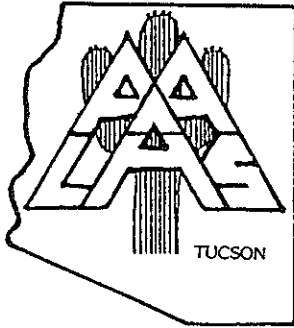

AALAS Summer Social

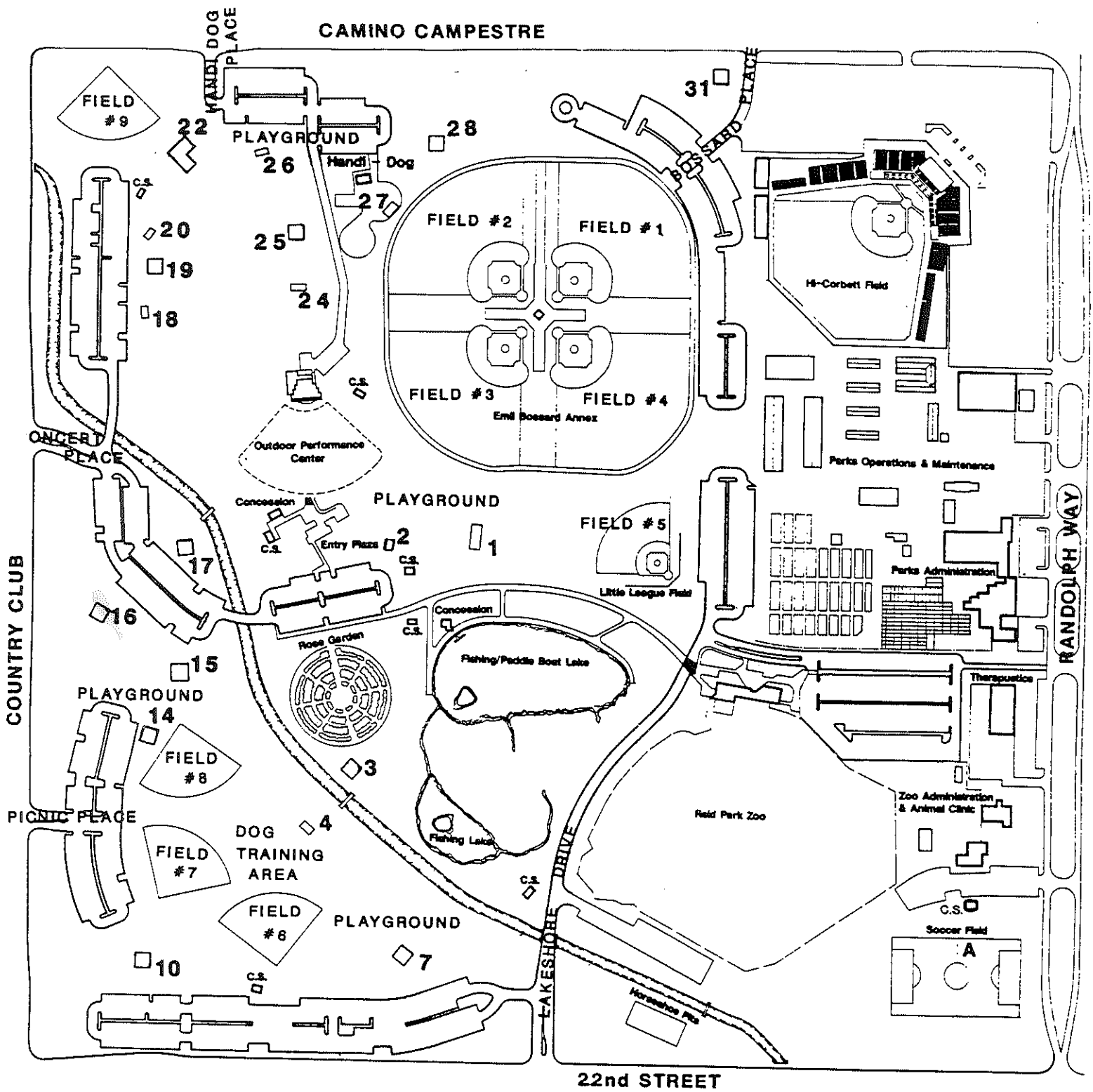
